



Request for Expressions of Interest

Provision of engineering, procurement, construction and operation services for a 100MW PV solar plant by MBS, an ALTEN Africa investee

1. **Middle Band Solar One Limited (MBSO)**, a company incorporated under the laws of the Republic of Nigeria, is seeking expressions of interest (EOI) from interested firms to carry out the engineering, procurement, construction and operation of 100 MW(ac) PV plant, to be located in Kogi State, Nigeria. MBSO has a generation license and has executed a PPA.
2. MBSO intends to invite reputable EPC contractors and OM operators, with previous experience with the engineering, procurement, construction and operation of PV plants, to the request for proposal (RFP) process.
3. The procurement process will be conducted in two stages, Request for Expression of Interest (EOI) and Request for Proposal (RFP).
